In accordance with Ontario Regulation 412/00 of the Education Act, enclosed for your information is the final distribution of Trustees for the Upper Grand District School Board for the 2022 municipal elections. It has been determined that District Board #18 will have ten (10) trustees distributed as follows:

In accordance with Ontario Reg. 412/00 of the Education Act, the Upper Grand District School Board at the March 22, 2022 Board Meeting approved the following:

- 1. The Upper Grand District School Board approve the determination of 10 trustee positions for the board, the same number who were elected to the board at the 2006, 2010, 2014, and 2018 regular elections.***
- 2. The Status Quo (Option A) trustee distribution, as outlined in Appendix “C” of the report entitled Trustee Determination and Distribution for the Upper Grand District School Board for 2022 dated March 8, 2022, be approved and submitted, no later than April 4, 2022 to the Ministry of Education, the election clerk for all municipalities within the board’s jurisdiction; and the secretary of every other board that is wholly or partially within the board’s area of jurisdiction.***
- 3. The Board approve that no areas in the jurisdiction of the Upper Grand District School Board be designated as low population areas.***
